Abstract

Higher education data are collected and reported by the federal government at different levels of aggregation. Some information is self-reported at the individual campus level. For example, Rutgers University has three individual campuses, and each branch has its own separately reported data for inputs such as net cost, undergraduate enrollment, and the proportion of low- and moderate-income students who enroll at each campus location. An institution such as Rutgers, however, also has only one value for the economic outcomes of its former students, combining all three branch campuses under a single earnings metric.

This paper presents an overview of federal higher education data, explores options for consolidating data collected at different units of observation, and concludes with recommendations for how the Social and Economic Mobility Classification could handle variables collected at different units of observation.

Introduction

While it sounds as though it should be easy, one of the most difficult things in measuring the outcomes of institutions is actually defining what an "institution" is. One may wonder how this could be—but it usually has to do with the way data are reported to the federal government and the different databases that capture such information. Some data are reported to the U.S. Department of Education's (ED) Integrated Postsecondary Educational Data System (IPEDS), while other information is only captured within the National Student Loan Data System (NSLDS). Both databases are important, but the information they capture often needs to be combined when evaluating institutions of higher education.

IPEDS Versus NSLDS

The information reported to IPEDS is captured on a more nuanced basis than what is captured by NSLDS. Specifically, if an institution has multiple branch campus locations, each self-reports its own information to IPEDS; this means that each individual campus has unique information for certain characteristics and outcomes. This includes inputs and outputs such as the annual net price that students need to cover, the size of the undergraduate population, the proportion of low- and moderate income (Pell Grant recipient) students, and each individual branch campus's graduation rate. To capture this information, each campus reports using a unique identifier, known as an IPEDS UnitID. For example, there are 6,681 unique IPEDS UnitIDs that are reported to ED.

The information captured within NSLDS is reported and presented in a different way. Rather than containing disaggregated information for each separate branch campus or location (as the IPEDS UnitID does), it often groups multiple branch campuses together, reporting only one outcome as an aggregate group for all campus locations. This reporting entity used by the NSLDS is called an Office of Postsecondary Education Identifier (OPEID). Information captured within NSLDS can include an institution's Cohort Default Rate and the median debt that students incur at each institution.³ Furthermore, ED also uses NSLDS data to capture the postenrollment earnings for students who attended an institution. Through an agreement with the U.S. Department of the Treasury, ED matches those who received federal student aid to the amount of income they earn a few years

later. Therefore, an OPEID is also used to calculate—and present—the earnings of former students who attended a specific institution. There are currently 5,253 unique OPEIDs reported to ED.⁴

The appendix provides more detail on the disconnect between UnitIDs and OPEID within IPEDS and NSLDS datasets. Based on currently available data, there are 345 OPEIDs that are associated with more than one UnitID; these 345 OPEIDs are connected with a total of 1,187 UnitIDs.⁵ Nearly 96 percent of these OPEIDs have five or fewer UnitIDs associated with them. Approximately 70 percent of OPEIDs with more than one UnitID are for-profit institutions, and many of these are certificate-granting institutions with locations in several states. The majority of the 104 not-for-profit public and private institutions that have more than one UnitID associated with them have three or fewer UnitIDs.

Example of Institutional Data Captured by IPEDS and NSLDS

Table 1 shows an example of how the differences in institutional data present when reported using an IPEDS UnitID (undergraduate enrollment, average net cost) in comparison with data that originated through NSLDS (earnings data) under a single OPEID.

Using as an example Rutgers University, a public institution located in New Jersey with multiple campuses, table 1 shows data from its three campus locations. The information on net cost and undergraduate enrollment, which are reported under three unique IPEDS UnitIDs, allows for disaggregated information at each of the three Rutgers campuses. The information on earnings—which is originated through NSLDS and accumulated under a single OPEID—displays this information as an aggregate, showing that the typical Rutgers student (at all three campuses combined) earns a median salary of \$65,661 at 10 years after initial enrollment. We can also see that there are 10,969 students represented by the earnings data across all three campuses.

Options for Combining IPEDS and NSLDS Data in a Classification of Social and Economic Mobility

When combining information from IPEDS and NSLDS, the options are limited. Intuition often leads researchers to try to produce the most granular measurement possible, which would take place at the campus or IPEDS UnitID level. This makes sense, as different campuses—even those under the same system—often charge different prices, enroll different types of students, and produce different outcomes. However, looking at the Rutgers example above, we can see that one major limitation exists when taking this approach: institutions that have multiple branch campuses—but fall under the same OPEID umbrella—are all assigned the same earnings data outcomes. Therefore, while former students from all three Rutgers's campuses show median earnings of \$65,661 at 10 years after initial enrollment, this method assumes that all campuses show the same employment outcomes, which may be misleading. And, while this doesn't affect all institutions, it does impact some more than others. While table 1 shows Rutgers' data, table 2 shows as an example information for Kent State University, a public institution located in Ohio. At each of its eight locations, students are shown to pay a different net price, yet all earnings are reported—and applied—under a single OPEID.

Using an Institution's OPEID in a Classification of Social and Economic Mobility

Since there is no way to disaggregate the information captured under an institution's OPEID—as with economic outcomes—for each campus, another option is to consolidate all of that data so that it can be matched with the broader OPEID data. Essentially, it presents IPEDS information in the way it would be reported if under a single OPEID. For characteristics such as undergraduate enrollment, this is easy: simply add all students captured under each individual IPEDS UnitID and apply them to the OPEID shared by all of the campus locations (e.g., Camden, New Brunswick, and Newark). This allows campus-level data to be presented under the single Rutgers OPEID (2629), showing that there are a total of 49,702 undergraduate students at all three of Rutgers' campuses.

Other IPEDS metrics require a bit more work to ensure the most accurate estimate when consolidating information under a single OPEID.

Using a Weighted Average for Some IPEDS Metrics

Sometimes, rather than combining IPEDS' UnitIDs to determine the total, it is necessary to calculate a weighted average. This occurs when there are differences not only in the number of students but also in the values within the variable that is being examined (across each campus location that shares a similar OPEID). For example, each of Rutgers' three campuses had a different number of students who paid a range of net prices. A weighted average allows the calculation to account for all students at these locations and determines their average net cost under a single OPEID.

To find a weighted net price, first find the total amount of net prices for which students were responsible at each campus location. For example, at the Rutgers University–Camden campus location, 562 first-year students captured within that cohort paid an average net cost of \$16,369 each. In total, that amount equals approximately \$9,199,378 of net costs at that campus location. Similarly, 3,451 students at Rutgers University–New Brunswick paid an average net price of \$23,035 each and were responsible for an approximate total of \$79,493,785 in net prices. At Rutgers University–Newark, 1,086 students paid an average of \$15,996 and were responsible for a total of \$17,371,656.

Knowing the total amount of students (5,099) and the total net costs that students are responsible at all three campuses (\$106,064,819) then allows for the calculation of a weighted average that can be used under Rutgers' shared 2629 OPEID. To do this, the total amount of net costs at all three campuses is divided by the total number of students within that cohort.

\$106,064,819 total net costs/5,099 students = \$20,801 (weighted) average net cost (OPEID 2629)

Conclusion

Defining an institution is critical to any socioeconomic mobility classification. Because any such classification is likely to include measurement of economic outcomes, it's most favorable to classify an institution at the OPEID level, as doing so often combines multiple campus locations under an institutional umbrella. Other inputs or outputs that are captured at the more granular IPEDS UnitID-level—such as the net cost that lower- and moderate-income students pay or the proportion of those students that an institution serves—should be consolidated under this definition to best ensure that they are reflective of all students who, in turn, attend an institution under this definition. No matter which methodology is used, it should be replicable and allow institutions to interpret the data used to classify its outcomes.
